Concept note:

The European Union recognises enlargement as a priority for geopolitical and security investments by the EU. In this evolving context, Local and Regional Governments (LRGs) are at the forefront of implementing reforms, building public trust, managing EU funds, and aligning local policies with EU standards. Yet, the full potential of LRGs remains under-recognised and under-utilised in the EU enlargement process. It is crucial to acknowledge that empowered Local and Regional Governments (LRGs) are tasked with accelerating economic and social integration and fostering closer ties between candidate countries and the EU.

The CEMR webinar seeks to raise awareness about evidence- based recommendations made by local government representatives from EU and candidate countries, highlighting not only the vital role of LRGs in fostering inclusive, resilient, and sustainable EU integration but also emphasising the need for multilevel dialogue and strengthening the capacity-building of LRGs and their associations. It also aims to develop a shared understanding of how to make enlargement more inclusive, sustainable, and locally rooted.

We believe there is a significant need to assess the current state of preparedness among LRGs and highlight areas requiring targeted support. Additionally, we aim to encourage forward-looking, practical suggestions and a collaborative approach in which LRGs are regarded as key actors in the decision-making process to better implement the EU agenda.

Based on the above, the following questions will be addressed during the webinar:

- To what extent are Local and Regional Governments currently equipped—technically, financially, and institutionally—to assume the responsibilities linked to EU pre-accession reforms and the implementation of the Acquis? Where do we see the most urgent capacity gaps?
- What mechanisms should be strengthened or newly established to ensure effective coordination between LRGs, their national governments, and EU institutions during the enlargement process?
- Looking ahead, what concrete actions—at both the EU and local levels—must be prioritised to empower LRGs as strategic actors in EU integration, particularly in fostering decentralised cooperation and inclusive development?

The webinar will facilitate the editing of a policy paper that includes the main findings and recommendations, which will serve as a tool for continuing CEMR's <u>work in EU enlargement</u>.
